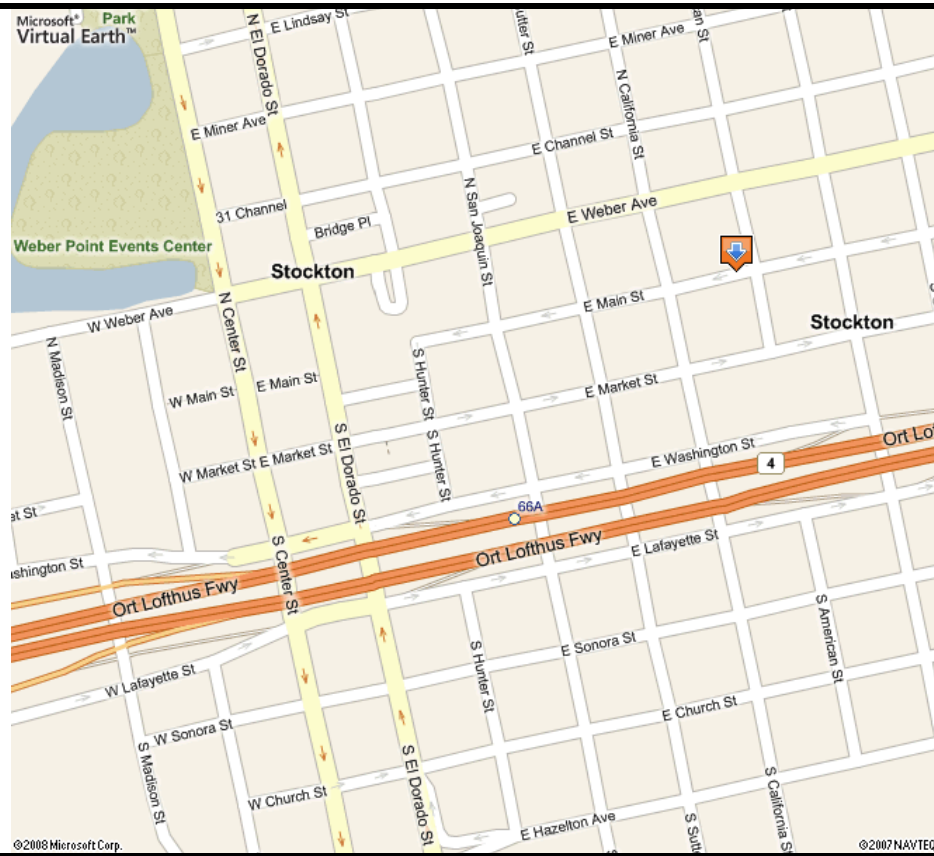


PRO PER CLINIC

WAITING TIME	Your wait time may vary depending on when you arrive at the Clinic and the number of people already being helped.																		
WHAT TO EXPECT AND BRING WITH YOU?	<p>When you arrive you will need to take a number from the ticket disbursement machine unless you are attending a workshop or signing up for document review. If this is your first time at the Clinic you will have to complete and sign a disclosure form. Clinic staff will discuss the issues you need help with, help you to understand the court system, and provide instructions on completing the necessary forms.</p> <p>You must bring a copy of all court documents relating to your case organized by date. If you do not have your court documents you must order your file one day prior to coming in for services. You can order your file online. You can not get copies of your file and be seen on the same day. Files will be returned every Friday.</p> <p>Please do not bring your children to the Clinic. Often times the issues that will be discussed are not appropriate for children to hear.</p> <p>Please note that the Pro Per Clinic does not provide legal advice and will not represent you in court. The Clinic is available to both parties.</p>
