Dear Judge Holland:

On June 28, 2010, the 2009-2010 San Joaquin County Grand Jury published its Final Report regarding the Stockton Unified School District. The report consists of three separate topics: 1) Public Appointment Process; 2) Student Truancy Follow Up from 2008-2009; and 3) 2008-2009 Grand Jury Report Follow Up of the 2007-2008 Grand Jury. The District was given ninety days to respond to the Grand Jury. Unfortunately, the current District administration was unaware of the report until late November 2010. In turn, the District requested extensions to respond to the reports and thanks the Grand Jury for the extensions.

Attached is the Board of Education's response to the 2009-2010 Grand Jury Report as adopted by the Board in open session on January 25, 2011. The response complies with Penal Code §933.05, which in part requires the following:

(a) For purposes of subdivision (b) of Section 933, as to each grand jury finding, the responding person or entity shall indicate one of the following:

- (1) The respondent agrees with the finding.
- (2) The respondent disagrees wholly or partially with the finding, in which case the response shall specify the portion of the finding that is disputed and shall include an explanation of the reasons therefor.

(b) For purposes of subdivision (b) of Section 933, as to each grand jury recommendation, the responding person or entity shall report one of the following actions:

- (1) The recommendation has been implemented, with a summary regarding the implemented action.
- (2) The recommendation has not yet been implemented, but will be implemented in the future, with a timeframe for implementation.



(3) The recommendation requires further analysis, with an explanation and the scope and parameters of an analysis or study, and a timeframe for the matter to be prepared for discussion by the officer or head of the agency or department being investigated or reviewed, including the governing body of the public agency when applicable. This timeframe shall not exceed six months from the date of publication of the grand jury report.

(4) The recommendation will not be implemented because it is not warranted or is not reasonable, with an explanation therefor.

SUBJECT: Response to 2009/2010 Grand Jury Report

### INTRODUCTION

The 2009/2010 Grand Jury released its Final Report on June 28, 2010. SUSD was required to respond in writing within 90 days of publication. Because of administrative transition, the response was not processed by the District, and on November 22, 2010, the Grand Jury reiterated its request for responses to three separate Cases: Public Appointment Process (Case No. 1009); Student Truancy Follow Up from 2008-2009 (Case No. 0909G); and 2009-2010 Follow Up of the 2008-2009 Grand Jury Report Follow Up of the 2007-2008 Grand Jury Report (Case No. 0909H).

### ANALYSIS

The reports detail multiple findings and recommendations.

Staff has analyzed the findings and recommendations for two reports: Public Appointment Process (Case No. 1009); and Student Truancy Follow Up from 2008-2009 (Case No. 0909G). Staff has provided responses for consideration by the Board of Education and 2009-2010 Follow Up of the 2008-2009 Grand Jury Report Follow Up of the 2007-2008 Grand Jury Report (Case No. 0909H). On January 11, 2011, the Board of Education formed an Ad Hoc Committee of Board members to review and recommend responses to the Board of Education..

### RECOMMENDATION

It is recommended that the Board of Education adopt the attached proposed response to the three 2009/2010 Grand Jury Reports for submission to the Presiding Judge of the San Joaquin County Superior Court by January 28, 2011.

**STOCKTON UNIFIED SCHOOL DISTRICT'S  
PROPOSED RESPONSE TO SAN JOAQUIN COUNTY GRAND JURY'S  
2009-2010 FINAL REPORT**

**I. Public Appointment Process (Case No. 1009)**

The San Joaquin County Grand Jury's summary of Case No. 1009 provides in full:

The 2009/2010 San Joaquin Grand Jury investigated the public appointment process. Hundreds of private citizens are appointed through this process to various public boards/commissions/committees (BCC) throughout the county. The loose guidelines of appointment have allowed appointed individuals to go unchecked. Without adhering to strict background checks, the appointment process lacks emphasis on fiduciary responsibility.

The Grand Jury next sets for the requirements pursuant to Government Code §§ 54970, 54971, 54972 and 54973 for establishing, and maintaining BCCs and requested responses to six findings and six recommendations from SUSD and fourteen other public entities.

The Grand Jury's findings and recommendations are as follows:

Findings

- F1. Some legislative bodies do not follow policies and procedures for BCC appointments. The Grand Jury is aware of at least one instance where an appointee was not required to complete an application prior to appointment.
- F2. Brown Act and fiduciary responsibility training is not routinely offered for BCC.
- F3. Recruitment for vacant BCC appointments lacks initiative.
- F4. BCC appointee performance is rarely reviewed.
- F5. Policy for BCC appointee removal is not always defined.
- F6. Criminal and credit background investigations are not performed on appointees.

## Recommendations

The Grand Jury recommends that all legislative bodies:

- R1. Develop or update policies and procedures for appointment of BCC members.
- R2. Provide and document Brown Act and fiduciary responsibility training to all appointees.
- R3. Utilize alternative sources to advertise vacant positions; i.e. Twitter, movie theaters, television, radio, announcements at public events.
- R4. Annually review appointee performance and take appropriate action.
- R5. Develop policy and procedures defining the processes for appointee removal.
- R6A. Develop criminal and credit check standards for appointees.
- R6B. Perform criminal and credit background checks on all appointees prior to appointment.

## District Response

Upon receipt of the Grand Jury's report in Case No. 1009, Public Appointment Process, District legal counsel reviewed the referenced Government Code sections (54970, 54971, 54972 and 54973) and concluded that those sections of the Government Code are inapplicable to the District. These sections of the Government Code are known as the Maddy Act and require that, "On or before December 31 of each year, each *legislative body* shall prepare an appointments list of all regular and ongoing boards, commissions, and committees which are appointed by *the legislative body of the local agency*. This list shall be known as the Local Appointments List." (Cal. Gov. Code, § 54972; emphasis added.) The Act defines a "legislative body" as "the board of supervisors or its chairman in the case of the county, or the city council or the mayor in the case of a city." (*Id.* at § 54971.) A "local agency" is defined as "a county or city, whether chartered or general law." (*Ibid.*) As such, the Act by its express terms does not include school districts.

Although not bound by the Maddy Act, the District does have one committee, the Bond Oversight Committee, that is similar in structure to the BCC's referenced by the Grand Jury. The structure, membership and duties of the Bond Oversight Committee are governed by statute, specifically Education Code §§ 15278 *et seq.* These sections of the Education Code, along with documents reflecting Board action with regard to the Bond Oversight Committee, and the policy for the Committee are attached hereto and incorporated into this response as Exhibit A.

## II. Student Truancy Follow Up from 2008-2009 (Case No. 0909G)

The San Joaquin Grand Jury provides the following reason for the investigation of student truancy:

The 2008/2009 Grand Jury became aware of inconsistent truancy reports (Consolidated Application) that were submitted to the California Department of Education (CDE) and State Controller's Office (SCO) by Lodi, Tracy and Stockton Unified School Districts during the 2007/2008 fiscal year. The 2008/2009 Grand Jury sent letters to the three school districts with a request for clarification of the differentials contained in the reports. The 2009/2010 Grand Jury chose to follow-up with individual investigations of each school district.

With regard to Stockton Unified specifically, the Grand Jury reports:

Stockton re-submitted a corrected and accurate Consolidated Application to the CDE and SCO on March 17, 2009. Incorrect data was pulled from the Truancy Reporting report and was for notification of habitual truancy rather than initial notifications of truancy as requested in the Consolidated Application. Data reported for mandated cost reimbursement is for the notification of initial truancy.

The Grand Jury's lone finding with regard to Stockton Unified is that "Stockton Unified School District resubmitted corrected Consolidated Applications for the 2007/08 school year and the truancy information reported for the 2008/09 school year was accurate."

### District Response

The District agrees with this finding of the 2009-2010 Grand Jury. In support of this agreement, the District provides responsive documentation attached hereto and incorporated into this response as Exhibit B.

### III. 2009-2010 Follow Up of the 2008-2009 Grand Jury Report Follow Up of the 2007-2008 Grand Jury Report (Case No. 0909H)

The Grand Jury explains the reason for its second follow up and provides in full:

The 2008/09 Grand Jury conducted a follow-up investigation to the report written by the 2007/08 Grand Jury, Case No. 08-07. The case originated with a written complaint containing specific allegations focused on several activities and events by the Stockton Unified School District (SUSD) that may have been inappropriate or possibly illegal. The 2008/09 Jurors wanted to determine if the Board of Education (Board) corrected the problems of the past and had implemented recommendations of the 2007/08 Grand Jury. Immediately following publication of the 2008/09 Grand Jury's Final Report, Case No. 01-08E, important events occurred in SUSD.

The 2009/10 Grand Jury conducted a follow-up investigation to find out if those events had any impact on the findings and recommendations contained in the 2008/09 report. The 2009/10 Grand Jury focused on recommendations that the Board disagreed with, did not act upon, or partially completed. The 2009/10 Grand Jury found that circumstances had changed since the 2008/09 investigation.

The Grand Jury made ten findings and 5 recommendations which are each addressed below.

#### FINDINGS/RESPONSES

**Finding # 1. The 2008/09 Grand Jury found Trustees periodically reviewed contracts and purchases made by management. Recent findings indicated this was not always the case. Information given to the Board by the previous Superintendent was not always given with enough lead time for the Board to study, nor was it always complete or accurate.**

Response to Finding #1. The District agrees with this finding.

The former Superintendent did not always allow enough lead time for the Board to study and analyze potential contracts prior to Board action. Since the arrival of Jason Willis as Chief Financial Officer and Carl Toliver as Superintendent, the Board has been provided additional time to review contracts and other documentation prior to action at Board meetings.

**Finding #2. Although the 2008/09 Grand Jury recommendation of developing a procedure for awarding consultant contracts had been implemented, the procedure was vague and open to interpretation. Presently, the interim Superintendent submits consultant requests to the Board for approval prior to hiring.**

Response to Finding #2. The District agrees with this finding.

The former Interim Superintendent began the practice of bringing all consultant contracts to the Board of Education for approval. The current Superintendent and CFO have continued this practice and provide to the Board both the consultant contract, as well as a copy of the Consultant Utilization form, which informs the Board of any current or past relationship between the District and the consultant. In October 2009, the Board of Education amended Administrative Regulation 3600 to ensure disclosure of consultant agreements. (Exhibit C)

**Finding #3. In September of 2009, the Board dismissed the Superintendent and appointed an interim Superintendent. The current management team appears to be strong and allows more time for planning. The interim Superintendent and management team now attempt to give information to the Board with more lead time that enables the Board to make better informed decisions.**

Response to Finding #3. The District agrees with this finding.

As explained above in Response to Finding # 2, the current Superintendent and Chief Financial Officer and the entire management team strive to provide the Board additional time to review contracts and other documentation prior to action at Board meetings.

**Finding #4. During the term of the previous Superintendent there were many misinterpretations of budgetary and economic policy among management and Trustees. This resulted in their inability to work together productively. The interim Superintendent now reviews the budget and expenditures weekly. All purchase order warrants are given to the Board for approval. The County Office of Education also reviews the budget quarterly and presentations are made to the budgetary committee.**

Response to Finding #4. The District agrees in part with this finding.

During the term of former Superintendent Amato, there were apparent misunderstandings and misinterpretations between the Board and then Superintendent Amato. Since Mr. Amato's departure, the former Board and Interim Superintendent, as well as the current Superintendent and current Board, have worked diligently to avoid misinterpretations regarding economic policy. For example, starting in October 2009, the Chief Financial Officer, Interim Superintendent and current Superintendent have provided comprehensive budget updates at most public Board meetings. Further, in October 2009 and December 2010, the Board of Education adopted Fiscal Accountability Plans to be transparent and proactive in addressing the current fiscal crisis. The Plans provide direction to staff on how to achieve cost savings and identify a process to continue identifying cost savings for the upcoming fiscal year. (Exhibit D)

**Finding# 5.** Prior to the dismissal of the previous Superintendent, the Board could not come to agreement on many issues facing SUSD.

Response to Finding # 5. The District agrees with this finding.

**Finding #6.** The Citizen's Bond Oversight Committee and Chief Financial Officer of the District review all bond proposals and expenditures. The District is still reviewing ways to maximize bond funds for high schools. Some projects have begun.

Response to Finding # 6. The District agrees with this finding.

**Finding #7.** The Trustees and management are currently exploring ways to integrate the FCMAT recommendations on a regular basis through their Five-Year Plan. The Board has reevaluated policies and procedures to address the current budget crisis and operational cuts.

Response to Finding # 7. The District agrees with this finding.

As explained in Response to Findings #2 and 4 above, the District has implemented practices and procedures to address the current budget crisis.

**Finding #8.** The creation of private non-profit foundations has not been implemented by SUSD. The interim Superintendent finds it difficult to operate foundations and conduct fundraising activities during hard economic times. Management and Trustees are exploring other ways to generate revenue. Various community groups and businesses have adopted individual schools and are providing support to those schools.

Response to Finding # 8. The District disagrees with this finding.

Administration and the Board of Education are working to revive the 1852 Foundation, a non-profit foundation, to raise funds for the District. In 2002, the Board created the SUSD 1852 Foundation. The purpose of the Foundation is "to benefit the District by enhancing the educational opportunities of District students and supporting District events." During the January 25, 2011 meeting, the Board appointed an Ad Hoc Committee of Board members to establish a process for selecting members of the community to serve on the Foundation Board of Directors.

**Finding #9.** The Board discontinued the use of the "Success for All" program. They were able to return a portion of the program for partial credit toward the balance owed. They are examining alternative uses for the remaining program materials.

Response to Finding # 9. The District agrees with this finding.

The District returned a portion of the materials for approximately \$140,000 in credit. Further, the District is currently working with local community organizations to distribute some of the remaining materials.

**Finding #10. The current hiring policy encourages qualified SUSD employees to apply for new positions, but maintains a competitive application process. All applications within and outside the District are considered and reviewed equally, with the position being awarded to the most qualified applicant.**

Response to Finding # 10. The District agrees with this finding.

## **RECOMMENDATIONS/RESPONSES**

**Recommendation #1. The Board require management to obtain legal counsel review of all contracts prior to Board consideration.**

Response to Recommendation #1. The District's Business Office has implemented this recommendation with regard to new contracts.

**Recommendation #2. The Board develop and approve policies that provide management direction on financial and administrative procedures of the District.**

Response to Recommendation #2. The District has implemented this recommendation.

The former Board and Interim Superintendent, as well as the current Superintendent and current Board, have worked diligently to develop and approve policies providing direction on financial and administrative procedures. For example, starting in October 2009, the Chief Financial Officer and both the interim Superintendent and current Superintendent have provided comprehensive budget updates at most public Board meetings. Further, in October 2009 and December 2010, the Board of Education adopted Fiscal Accountability Plans to be transparent and proactive in addressing the current fiscal crisis. The Plans provide direction to staff on how to achieve cost savings and identify a process to continue identifying cost savings for the upcoming fiscal year. Also, in October 2009, the Board of Education amended Administrative Regulation 3600 to ensure disclosure of consultant agreements. (Exhibits C and D) Finally, in December 2010, the Board Education submitted a qualified First Interim Budget with the County Office of Education and in turn has been assigned a Fiscal Expert to advise the District regarding the District finances.

**Recommendation # 3. The Board and Superintendent continue to explore a variety of conventional and creative supplemental funding sources for district operations.**

Response to Recommendation #3. The District has implemented this recommendation.

The Board continues to explore both conventional and creative supplemental funding sources for District operations which follow up on measures already put into place by the District. For example, the Board authorized the District to enter into an agreement which would generate revenue in exchange for placing inconspicuous cell phone towers on school district property. In addition, the Board is exploring the possibility of permitting paid advertising on its property and is currently reviewing responses to a request for proposals for such services.

**Recommendation #4.** The Board make careful and calculated decisions based on “best practices” and economic considerations when formulating plans for the future.

Response to Recommendation #4. The District has implemented this recommendation.

As explained above in Response to Recommendation #2, the District has already taken a number of steps to make careful and calculated economic decisions. The response to Recommendation #2 is incorporated as the response to Recommendation #4.

**Recommendation #5.** Trustees conduct themselves in a manner which displays to the public their willingness to work with each other and management to the betterment of educating children.

Response to Recommendation #5. The District has implemented this recommendation.

The current Board is dedicated to its responsibility to professionally work together for the betterment of the students of the District. To this end, the Board shall participate in training regarding governance and the role of the Board.

# Exhibit A

**STOCKTON UNIFIED SCHOOL DISTRICT**  
**Policy for the Measure C and Measure Q Citizens' Oversight Committee**

---

**Structure and Operating Guidelines**

The California Constitution and Education Code provisions require the Governing Board (the "Board") to establish a citizens' oversight committee within 60 days of the certification of a successful bond election. This policy provides the procedures and authorization for the operation of that committee.

1. **Purpose of the Committee.** The Measure C and Measure Q Citizens' Oversight Committee (the "Committee") shall exist for the duration of the Measure C and Measure Q program. The purpose of the Committee shall be to inform the public about the expenditure of the bond proceeds, at least annually, in a written report. In carrying out this purpose, the Committee shall:
  - a. Actively review and report on the proper expenditure of taxpayer's money for school construction;
  - b. Advise the public as to whether the Stockton Unified School District ("District") is in compliance with the requirements of Article XIII A, Section 1 (b)(3) that provides that:
    - i. Bond revenues are expended only for the construction, reconstruction, rehabilitation or replacement of school facilities, including furnishing and equipping of school facilities, or the acquisition or lease of real property for school facilities;
    - ii. No funds are used for any teacher or administrative salaries or other non-project related school operating expenses;
    - iii. A list of projects to be funded was included on the ballot; and
    - iv. An annual independent financial audit and an annual independent performance audit are performed.
2. **Activities of the Committee.** The Committee may engage in any of the following activities in furtherance of its purpose:
  - a. Receive and review copies of the annual independent financial audit and the annual independent performance audit.
  - b. Inspect school facilities and grounds.
  - c. Issue annual reports of the results of its activities not later than 90 days after the close of the District's fiscal year or the first Board meeting in February.

- d. Receive and discuss annual financial audit report and the annual performance audit report. Provide an annual update to the Board and community on these reports.
- e. Receive and review the District's deferred maintenance proposals, plans or reports.
- f. Elect a spokesperson(s) who will act as representative of the majority of the Committee, as recorded by a vote of the Committee during a regular meeting.
- g. Submit reports and public statements that represent the view of the majority of the Committee.
- h. Reviewing efforts by the school district to maximize bond revenues by implementing cost-saving measures, such as:
  - (a) mechanisms designed to reduce the costs of professional fees.
  - (b) mechanisms designed to reduce the costs of site preparation.
  - (c) recommendations regarding the joint use of core facilities.
  - (d) mechanisms designed to reduce costs by incorporating efficiencies in school-site design.
  - (e) recommendations regarding the use of cost-effective and efficient reusable facility plans.
- i. Review District's school building repair funding plan comprised of local and state bond funds, and other funding sources.
- j. Perform duties as indicated on Exhibit A.
- k. Perform additional duties as prescribed by the Board.

**3. Membership of the Committee.** The Board shall appoint the Committee members. The Committee shall consist of at least seven (7) members to serve for a term of two (2) years without compensation and for no more than two (2) consecutive terms. The Committee may not include any employee or official of the District or any vendor, contractor, or consultant of the District. The Committee must include:

- a. One member who is active in a business organization representing the business community located within the school district;
- b. One member active in a senior citizens' organization;
- c. One member active in a bona fide taxpayer organization;
- d. One member who is the parent or guardian of a child enrolled in the school district; and
- e. One member who is a parent or guardian of a child enrolled in the school district and who is active in a parent-teacher organization.

4. **Meeting Procedures of the Committee.**

- a. Regular attendance by Committee members is essential to effective operation of the Committee. If a Committee member is unable to attend regularly scheduled meetings, the Board may appoint a replacement for that member on recommendation of the Superintendent. If a Committee member has two consecutive unexcused absences as reported to the Chairperson prior to the meeting, the Committee shall recommend that the Board remove the member from the panel and seek a replacement. The replacement member shall represent the required committee membership background.
- b. The Superintendent will notify the Board in writing of any vacancies and ask the Board for recommendations. If none, the Superintendent will notify the community of vacancies by informing school parent groups and by other means of communication. The Superintendent will recommend members to be appointed who meet the qualifications stated. Appointment of members will require two Board meetings with discussions on the first and action on the second.
- c. The Committee serves as an advisory body to the Board and serves at the pleasure of the Board.
- d. The Committee shall meet at least once each year.
- e. The Committee shall elect a chairperson each year.
- f. The Chairperson, in consultation with District Staff, will establish an agenda for each meeting.
- g. Regular meeting dates, times and place shall be established by the Committee and shall be published/posted in accordance with the Ralph M. Brown Act and with District Procedures. All Committee proceedings shall be open to the public and shall be subject to the provisions of the Ralph M. Brown Act.
- h. The Committee shall operate under the latest edition of Robert's Rules of Order. Committee actions and decisions shall be made and recorded as individual votes, noting the committee member's name and response. Committee decisions shall be by majority vote of the members of the Committee present, provided that there is a quorum. All documents received by the Committee and reports issued by the Committee shall be a matter of public record.
- i. Parents, community members, and news media representatives shall be encouraged to attend Committee meetings. Schools shall be notified of meetings and agendas.
- j. Members of the audience shall have an opportunity to address the Committee. Notice of Committee meetings and Committee actions shall be reported at Board meetings. Notices shall be given to schools, whose principals shall be responsible to ensure that parent groups and school site council are notified.

- k. Reports by the Committee shall be presented at Board meetings.
- l. Reports and documents received by the Committee shall be placed on either the District's or other web site.
- m. Committee members shall certify annually that they do not have a conflict of interest, as defined in Proposition 39 requirements.

5. **District Support of the Committee.** The Board, as recommended by the Superintendent, shall provide support to the Committee without the use of bond funds consisting of:

- a. Technical assistance and administrative assistance in furtherance of the Committee's purpose as the Board deems necessary; and
- b. Sufficient resources to publicize the conclusions of the Committee.

CALIFORNIA CODES  
**EDUCATION CODE**  
SECTION 15278-15282

**15278.** (a) If a bond measure authorized pursuant to paragraph (3) of subdivision (b) of Section 1 of Article XIII A of the California Constitution and subdivision (b) of Section 18 of Article XVI of the California Constitution is approved, the governing board of the school district or community college shall establish and appoint members to an independent citizens' oversight committee, pursuant to Section 15282, within 60 days of the date that the governing board enters the election results on its minutes pursuant to Section 15274.

(b) The purpose of the citizens' oversight committee shall be to inform the public concerning the expenditure of bond revenues. The citizens' oversight committee shall actively review and report on the proper expenditure of taxpayers' money for school construction. The citizens' oversight committee shall advise the public as to whether a school district or community college district is in compliance with the requirements of paragraph (3) of subdivision (b) of Section 1 of Article XIII A of the California Constitution. The citizens' oversight committee shall convene to provide oversight for, but not be limited to, both of the following:

(1) Ensuring that bond revenues are expended only for the purposes described in paragraph (3) of subdivision (b) of Section 1 of Article XIII A of the California Constitution.

(2) Ensuring that, as prohibited by subparagraph (A) of paragraph (3) of subdivision (b) of Section 1 of Article XIII A of the California Constitution, no funds are used for any teacher or administrative salaries or other school operating expenses.

(c) In furtherance of its purpose, the citizens' oversight committee may engage in any of the following activities:

(1) Receiving and reviewing copies of the annual, independent performance audit required by subparagraph (C) of paragraph (3) of subdivision (b) of Section 1 of Article XIII A of the California Constitution.

(2) Receiving and reviewing copies of the annual, independent financial audit required by subparagraph (C) of paragraph (3) of subdivision (b) of Section 1 of Article XIII A of the California Constitution.

(3) Inspecting school facilities and grounds to ensure that bond revenues are expended in compliance with the requirements of paragraph (3) of subdivision (b) of Section 1 of Article XIII A of the California Constitution.

(4) Receiving and reviewing copies of any deferred maintenance proposals or plans developed by a school district or community college district, including any reports required by Section 17584.1.

(5) Reviewing efforts by the school district or community college district to maximize bond revenues by implementing cost-saving measures, including, but not limited to, all of the following:

(A) Mechanisms designed to reduce the costs of professional fees.

(B) Mechanisms designed to reduce the costs of site preparation.

(C) Recommendations regarding the joint use of core facilities.

(D) Mechanisms designed to reduce costs by incorporating efficiencies in schoolsite design.

(E) Recommendations regarding the use of cost-effective and efficient reusable facility plans.

15280. (a) The governing board of the district shall, without expending bond funds, provide the citizens' oversight committee with any necessary technical assistance and shall provide administrative assistance in furtherance of its purpose and sufficient resources to publicize the conclusions of the citizens' oversight committee.

(b) All committee proceedings shall be open to the public and notice to the public shall be provided in the same manner as the proceedings of the governing board. The citizens' oversight committee shall issue regular reports on the results of its activities. A report shall be issued at least once a year. Minutes of the proceedings of the citizens' oversight committee and all documents received and reports issued shall be a matter of public record and be made available on an Internet website maintained by the governing board.

15282. (a) The citizens' oversight committee shall consist of at least seven members to serve for a term of two years without compensation and for no more than two consecutive terms. While consisting of a minimum of at least seven members, the citizens' oversight committee shall be comprised, as follows:

(1) One member shall be active in a business organization representing the business community located within the district.

(2) One member shall be active in a senior citizens' organization.

(3) One member shall be active in a bona fide taxpayers' organization.

(4) For a school district, one member shall be the parent or guardian of a child enrolled in the district. For a community college district, one member shall be a student who is both currently enrolled in the district and active in a community college group, such as student government. The community college student member may, at the discretion of the board, serve up to six months after his or her graduation.

(5) For a school district, one member shall be both a parent or guardian of a child enrolled in the district and active in a parent-teacher organization, such as the Parent Teacher Association or schoolsite council. For a community college district, one member shall be active in the support and organization of a community college or the community colleges of the district, such as a member of an advisory council or foundation.

(b) No employee or official of the district shall be appointed to the citizens' oversight committee. No vendor, contractor, or consultant of the district shall be appointed to the citizens' oversight committee. Members of the citizens' oversight committee shall, pursuant to Sections 35233 and 72533, abide by the prohibitions contained in Article 4 (commencing with Section 1090) and Article 4.7 (commencing with Section 1125) of Division 4 of Title 1 of the Government Code.



**BYLAWS  
OF  
THE STOCKTON UNIFIED SCHOOL DISTRICT  
MEASURE "C" CITIZENS' OVERSIGHT COMMITTEE**

**Section 1. NAME**

The name of this Committee shall be the Stockton Unified School District Measure "C" Citizens' Oversight Committee (herein referred to as the "Committee").

**Section 2. PRINCIPAL OFFICE**

The principal office of the Committee for the transaction of its business is located in San Joaquin County, California. The Committee may change the principal office from one location to another. Any such change of location must be noted by the Secretary of the Committee.

**Section 3. OBJECTIVES AND PURPOSES**

The primary objectives and purposes of this Committee shall be to monitor and report on the expenditure of Measure "C" bond proceeds and to inform the public concerning the expenditure of the bond proceeds.

**Section 4. MEMBERS**

This Committee shall have at least 7 members, as established by the Stockton Unified School District's Governing Board. All members shall be voting members. The members shall elect a Chairperson and a Secretary.

**Section 5. GENERAL POWERS**

The Committee shall have powers and authority as established by Education Code Section 15278.

**Section 6. POWERS**

The Committee shall have the power to:

- (a) Perform any and all duties imposed on them collectively or individually by law, or by these Bylaws;
- (b) Meet at such times and places as required by these Bylaws;
- (c) Review, audit and report on the expenditure of Measure "C" bond proceeds.

## Section 7. ACTIONS AND REPORTS

(a) The Committee may engage in the following activities:

(1) Receiving and reviewing copies of the annual, independent financial audit required by subparagraph (C) of paragraph (3) of subdivision (b) of Section 1 of Article XIII A of the California Constitution.

(2) Inspecting school facilities and grounds to ensure that bond revenues are expended in compliance with the requirements of paragraph (3) of subdivision (b) of Section 1 of Article XIII A of the California Constitution.

(b) The Committee shall cause an annual report to be furnished not later than 90 days after the close of the District's fiscal year or the first Board meeting in February to all District Governing Board members, which report shall contain the following summary information in appropriate detail:

(1) Committee's ongoing review summary of activities on the expenditure of Measure "C" bond proceeds;

(2) Advice given to the public (annually/quarterly) whether the estimated tax to be levied exceeds \$60 per \$100,000 assessed value (Cal. Const. Art. XIII A, Section 1(b)(3).)

(3) Results of whether bond proceeds were expended on project costs and not used on teacher or administrative salaries or other operating expenses.

(4) Provide a copy of any report issued to the public in the event the Committee determined Measure "C" funds were spent improperly or wastefully.

The annual report shall be accompanied by any report thereon of independent accountants, or, if there is no such report, the certificate of an authorized officer of the Committee that such statements were prepared without audit from the books and records of the Committee.

The Committee shall also cause, when appropriate, to be published a public report containing the information on any improper use of Measure "C" proceeds.

## Section 8. TERMS OF OFFICE

Each Member shall hold office for two years without compensation and for no more than two consecutive terms. The Governing Board of the District shall be notified of any vacancy and shall have the sole power to fill all vacancies.

Section 9. PLACE OF MEETINGS; MEETINGS BY TELEPHONE OR OTHER TELECOMMUNICATIONS EQUIPMENT

All meetings shall comply with Government Code Section 54950, et seq. (the "Brown Act"). Meetings shall be held at the principal office of the Committee unless otherwise provided by the members or at such place within the District that has been designated from time to time by resolution of the members. Meetings not so held shall be valid only if held on the written consent of all members given either before or after the meeting and filed with the Secretary of the Committee or after all members have been given written notice of the meeting as hereinafter provided for special meetings of the Committee. Any meeting, regular or special, may be held by conference telephone, video-screen communication, or communications equipment, so long as all members participating in such meeting can hear one another, public participation is afforded, and the meeting meets all applicable requirements of the Brown Act.

Section 10. REGULAR MEETINGS

The Committee shall meet at least once each year.

Section 11. SPECIAL MEETINGS

Special meetings of the Committee may be called by the Chairperson or by a majority of the members and called pursuant to Brown Act requirements.

Section 12. QUORUM FOR MEETINGS

A quorum shall consist of a majority of the members.

Section 13. MAJORITY ACTION AS COMMITTEE ACTION

Every act or decision done or made by a majority of the members present at a meeting duly held at which a quorum is present is the act of the Committee.

Section 14. CONDUCT OF MEETINGS

Meetings of the Committee shall be presided over by the Chairperson of the Committee, or, if no such person has been so designated or, in his or her absence, the Secretary of the Committee or, in the absence of each of these persons, by a temporary Chairperson chosen by a majority of the Directors present at the meeting. The Secretary of the Committee shall act as secretary of all meetings of the Committee, provided that, in his or her absence, the presiding officer shall appoint another person to act as Secretary of the meeting.

Section 15. VACANCIES

Vacancies on the Committee shall exist on the death or resignation of any member.

Any member may resign effective upon giving written notice to the Chairperson of the Committee, member, the Secretary, or the Committee, unless the notice specifies a later time for the effectiveness of such resignation.

Vacancies on the Board may only be filled by the Governing Board of the School District.

Section 16. DUTIES OF THE CHAIRPERSON OF THE COMMITTEE

If a Chairperson of the Committee is elected, he or she shall assume all duties normally associated with that office. The Chairperson of the Committee shall conduct the meetings of the Committee. The Chairperson shall, when present, preside at all meetings, and shall see that all orders and resolutions of the Committee are carried into effect. The Chairperson shall: put to a vote and announce the results of actions taken on questions before the Committee; resolve all questions of order (subject to appeal); call special meetings when deemed necessary; and shall exercise and perform such other duties as may be prescribed by the Committee from time to time.

Section 17. DUTIES OF SECRETARY

The Secretary shall:

- (a) Keep at the principal office of the Committee the original, or a copy of the Bylaws, as amended or otherwise altered to date.
- (b) Keep at the principal office of the Committee or at such other place as the Committee may determine, a book of minutes of all meetings, recording therein the time and place of holding, whether regular or special, how called, how notice thereof was given, the names of those present or represented at the meeting, and the proceedings thereof.
- (c) See that all notices are duly given in accordance with the provisions of these Bylaws or as required by law.
- (d) Be custodian of the records.
- (e) In general, perform all duties incident to the office of Secretary and such other duties as may be required by law, or by these Bylaws, or which may be assigned to him or her from time to time by the Committee.

The Committee may request that the District provide administrative assistance to the Secretary by providing a staff member to take or transcribe the minutes of Committee meetings and maintain the book of minutes of the meetings.


Section 18. AMENDMENT OF BYLAWS

**SUBJECT: Approval of Amendment to Administrative Regulation (AR) 3600 –  
Consultants**

**INTRODUCTION:**

Members of the Board of Education and employee organizations have expressed concern over the hiring of consultants. District staff has operated under a consultant employment practice for many years in which annual non-instructional consultant contracts under \$50,000 did not require Board approval while all consultant contracts involved with student instruction were brought to the Board for approval. It is the desire of the trustees that ALL potential consultants, regardless of fees, be brought before the Board for consideration.

**ANALYSIS:**

The attached regulation defines consultants governed by the regulation and amends the current practice of the \$50,000 limit. The new Administrative Regulation requires that all non-instructional consultants be brought before the Board for consideration and approval. The existing practice of having Board approval for all consultants dealing with student instruction is also included. The regulation also delineates information required to be submitted by all consultants as part of the employment process regardless of monetary limits.

**RECOMMENDATION:**

It is recommended that the Governing Board adopt the amendment to Administrative Regulation 3600 - Consultants.

### **EXTERNAL**

The potential Consultant shall submit an application or introduction letter to provide consultancy services, which shall contain at least the following information:

- Names of the Consultant and individuals working for Consultant
- Disclosure of any previous employment relationship with the District by any employee or independent contractor working for or with Consultant
- Purpose and goal of the Consultant and the services to be addressed by the Consultant
- Documentation and references of demonstrated results in similar work
- How the quality of services of the Consultant are to be measured

Prior to recommending the contract for Consultant to the Board of Education, District staff shall review the following:

- The source of District funds to be utilized to pay for the Consultant
- The amount and term of the contract

Prior to recommending the contract for Consultant to the Board of Education, District staff shall review the following:

- The source of District funds to be utilized to pay for the Consultant
- The amount and term of the contract
- How the Consultant impacts current or future District alternatives
- What other internal or less expensive options are available, developed and evaluated
- How the quality of services will be measured, and by whom
- Who from the District reviewed and recommended the Consultant
- What, if any, enduring skills and knowledge are to be gained
- How is the issue addressed by the Consultant to be substantiated and defined, and which stakeholders, if any, have provided input with regard to the Consultant

The information gathered from the above external and internal procedures shall be included in the Board agenda item recommending the engagement of the Consultant.

**Resolution to Adopt Fiscal Accountability Plan**

WHEREAS, the Stockton Unified School District Governing Board ("Board") has a fiduciary responsibility to the Stockton community to ensure the effective use of public funds that offer the best possible education for the city's children;

WHEREAS, according to state Education Code the Board has an obligation to make timely, periodic reports to the San Joaquin County Office of Education assuring that the District remains a fiscally solvent organization;

WHEREAS, the California economic and fiscal outlook for the coming years continues to remain weak which will likely create budgetary challenges for education and local education agencies including the District;

WHEREAS, the District continues to operate with significantly less unrestricted General Fund revenue from the State than in prior years;

WHEREAS, the budgetary challenges ahead for the District and the work associated with dealing with these challenges will consume a lot of staff's time and attention and therefore their focus should be on current and upcoming financial activity for the organization;

WHEREAS, the District must be able to fulfill its obligation to continue day-to-day operations that allows appropriate educational services to be delivered to students;

NOWHEREFORE, BE IT RESOLVED that:

As part of the District's ongoing efforts to exercise transparency and proactive actions to deal with ongoing reductions in funding, staff will either continue or establish the following practices through the 2010-11 fiscal year:

- 1) Continue the current hiring freeze in place through 2010-11 except for those necessary services for the District determined through an appeals process, i.e. Hiring Review Form and process; and
- 2) Implement a freeze on all overtime for employees except for those circumstances deemed critical to the organization's goals and approved through the Superintendent and Chief Financial Officer;
- 3) Following the guidelines of the District's contractual obligations with its bargaining units, enforce limits on employees' ability to accrue and carryover comp time.
- 4) Re-evaluate funding sources for personnel and where appropriate, shift support for those positions to restricted resources.

- 5) Re-affirm and communicate expected, consistent practices for pay of substitutes throughout the District to administrators and managers;
- 6) Evaluate and deploy a consistent and efficient process for documenting employee leave to ensure the most efficient use of resources in accounting for employee's time away from the District;
- 7) Continue to re-evaluate existing contractual obligations with outside vendors and service-providers in an effort to reduce costs for the same, high-quality services;
- 8) Complying with the Board's adopted administrative regulation (AR) 3600 staff will bring forward all instructional and non-instructional consulting contracts for approval by the Board;
- 9) Staff will place the Purchase Order Board Report on the Board agenda as an informational item which lists all vendors authorized for payment in the prior month. The report will include the vendor name, total amount authorized, and funding source;
- 10) Staff will continue to place the Monthly Financial Activity report on the Board agenda as a consent item which provides a summary review of spending activity to date for the District. The report includes broad expenditure categories for the General Fund including a distinction between actual expenditures and encumbrances;
- 11) In compliance with Education Code, Staff will provide periodic updates to the Board defined as 1<sup>st</sup> Interim, 2<sup>nd</sup> Interim, and Unaudited Actuals that includes but is not limited to: a presentation that explains major changes in the budget since the last reporting period and the impact to District's budget as a result of outside circumstances such as the State budget; and
- 12) Continue update of the District's website dedicated to provide information about and related to the 2011-12 budget development process including but not limited to: (a) posting of historical years of the District's financial activity, (b) all presentations made to the Board and public, (c) relevant news articles, and (d) Frequently Asked Questions.

As a part of the 2011-12 budget development process for the District, the following actions will take place:

- A. As approved by the Board, staff will work with the Fiscal Crisis and Management Assistance Team's (FCMAT) to provide the data necessary for them to complete their independent, third-party, comprehensive financial review of the District's current and future year budget assumptions; and

- B. A Budget Update presentation will be given by the Superintendent and Chief Financial Officer at regular Board meetings when there is additional information regarding the District's budget and other considerations impacting the budget;
- C. Present budget consistent with the Association of School Business Officials (ASBO) standards and public budgets with per-pupil allocations for each school.






